#### **MAYOR'S REPORT**

Madisyn Shore, Water Clerk, gave a presentation on taking online payments with the company Court Money. Saying, they are a local company out of Marion, IL, and I have been working with Tracy Rone. Court Money states that they are "...a service provider of credit card and debit card transactions, at no cost to the government agency." They allow for many different types of payment transactions (rental, bail, court, permits) - for now, we are only looking at using the service for water/utility payments. How much does it cost? For the City of Havana \$0, no startup, intermediate, or termination costs. For customers / public: transaction fee (non - negotiable) \$1.75 for transactions \$50.00 and under and 3.5% for transactions over \$50.00. When would this change take place? 1-2 business days to get a "link" set-up and functioning after receiving signed paperwork from me. Then it, hopefully, only takes a few minutes to add the link to our City of Havana website. Why add this feature? No cost to the City of Havana, can cut back the amount of delinquent/missed payments, payments are available to be made 24/7 and are processed immediately and no issues with NSF or rejected payments. Court Money covers all transaction details and complaints. Ranges from payments not going through, to disputed transactions. Direct line for us (City) in case of mixed payments or issues. Why add this feature? Does not need to sync with our billing system, as there is an online Court Money portal where we (City) can view the payments made and apply them as shown. All payments send an email receipt to both me and the customer as confirmation of received payment. All payments provide a date/time stamp, so that we can know exactly when a payment was made. No issues with cyber security hacking or identity theft in the past (small companies are not

large targets). Court Money does not store any customer financial information to its servers. Get quarterly audits to ensure customer security is as safe and secure as possible. Money from Court Money will get deposited every Monday via ACH (excluding holidays in which case the deposit would be the following business day).
