I have been communicating with Steve Kline with the Economic Development Group and he has asked that I contact you. I will copy below, my last communication with him:

I see that the Havana City Council voted to move forward with the Business Development District. Congratulations! We understand that your next step is to evaluate all the properties proposed to be in the District.

The Havana Park District Board is concerned that part of our Riverfront Park is in the BDD at this point. Our Park land is not a business, nor is it developable, and additionally, we are a separate tax exempt government entity. No part of our Riverfront Park that you have included in the initial BDD group of properties generates sales tax either.

For these reasons, we are specifically asking to have our Riverfront Park property removed from the Business Development District as you go through and finalize the new District area.

Thank you for your consideration. Please let me know if you have any questions at all. Gracie~

# He responded:

Please contact the Mayor and discuss this with her. We'll adjust the BDD Study Boundary as directed by the City, but I do not understand why the Park District would not want this area to be included in the Business Development District. The BDD has nothing to do with real estate taxes, or TIF. If Riverfront Park is excluded from the BDD Area, the City would not be able to use future BDD funds it generates in the BDD Area to assist the Park District with any improvements along the riverfront.
