Alderperson Chaney asked if 32 people moved out this month. City Treasurer, Alex Noble said this was over a period of time. I don't know why all of the Clerk of the Water Department check# 73188 keeps showing up it should have been voided out, because it didn't print correctly. That will be the amount that will be coming back to the City from water accounts. Water Clerk, Madisyn Shore and I have been talking about just doing a transfer instead of cutting a check unless that is how the council wants it done. Then you will see a bunch of names and that is the amount that they are getting reimbursed. Alderperson Cooper asked if they had an outstanding balance, was it taken out of their meter deposit. City Treasurer, Alex Noble said yes, it would be adjusted to their account or a check would be cut to them if the City owed them money. Alderperson Chaney asked about the David Alan Badger check. It said it was for QR Codes in the amount of \$1,500.00. Mayor Stadsholt said it was for the Historic History Day on August 13, 2022. He's been working with Economic Development Coordinator, Brenda Davenport-Fornoff. Alderperson Cooper said on the invoice it also says sponsorship. Mayor Stadsholt said that it is for the History Day that the City is sponsoring for Economic Development and she is working on QR codes with him and he's doing a little booklet to hand out on Saturday when the American Countess docks. It's coming out of ARPA funds. Alderperson Cooper said these are public funds for a private business and I don't know exactly what we are getting. Alderperson Ray said I thought we have already addressed it. Alderperson Cooper said we did and that's why this needs to be a thorn that everybody makes clear. Mayor Stadsholt said that doesn't have anything to do with the quarterly that we had on the agenda two month ago. This is a different project that she is working on with Economic Development. Alderperson Chaney said I thought Economic Development Coordinator, Brenda Davenport-Fornoff did the QR codes with her son. Mayor Stadsholt said I wish she was here to answer your questions, but she is on vacation this week. It is for History Day on August 13, 2022. Alderperson Cooper said it doesn't seem right to use city funds to sponsor a private business. Alderperson Ray agreed. Alderperson Urish said if we are paying for work completed that's one thing and if he's publishing a book that references the QR codes for location, that's one thing. Alderperson Urish asked where are we at on the ARPA funds, because we already approved Economic Development Coordinator, Brenda Davenport-Fornoff to spend American Rescue Plan Program Fund Allocation. Alderperson Cooper said I guess what the question is, is that the price it would cost if someone else did it, because then you would know the fair value of the QR codes is there anything above that is sponsorship. I don't think we can give a sponsorship to a private business. Alderperson Chaney said it is coded to Mayor/Hospitality. City Treasurer, Alex Noble said the way it is coded it is not coming out of the ARPA funds, but we can easily change the coding in our accounts payable system. Alderperson Cooper said I think we just need a more information what it's for. The problem is if we don't approve this then it's too late. Alderperson Ray said we could exclude it from the Finance report. Mayor Stadsholt said before you exclude it, I wish Economic Development Coordinator, Brenda Davenport-Fornoff were here to speak to it. Perhaps it's already completed because she was under the impression because all of you at the table voted for her to use ARPA funds. That was part of her ARPA funds and that she could go forward with it. Alderperson Urish said my question with the council is, we want to empower Brenda to go do things. It's no different than Jewel as an employee. Brenda has to be able to have a budget. We did approve for a percentage of the ARPA funds to be available to her to go do things on behalf of Economic Development. If this were coded differently, coded under ARPA and Economic Development that would be something that as a council we did approve. Now if we have a problem with her bid letting process or something like that, that would be a different question. But we do want to give her some level of autonomy as an employee to go do things. I think that's one side of the equation. I think we do need to address is this hospitality or is this ARPA. There being no further questions, the motion passed with the following vote:
