We are in Florida about seven months out of the year. But, I love coming back to my home and small town America. I started through the Leadership Academy at Spoon River College. Our church was cooking at the Riverside Club and being a home economics teacher and licensed in sanitation for about 25 years. I was appalled, because as I would be mixing my cookie dough, plaster would be falling down from the ceiling, there were birds living

We only cook on Tuesdays now, I am making pies next month, and they told me to make for 45 people. Therefore, I love doing that. It is very rewarding. I love the Riverside Club. It is a landmark in our community. It has been improved immensely. I am very proud of it. I have donated 15 years, I believe, on the board of that organization; I am Secretary when I am here. Therefore, when it does go up for tax sell those liens have to be satisfied when the sell occurs.
