ECONOMIC DEVELOPMENT REPORT

DISCUSSION: Economic Development Coordinator, Brenda Davenport-Fornoff reported on the following items:

- I put in each of your boxes, one of the pamphlets for the Spark! Places of Innovation Smithsonian Museum on Main Street.
- I've been updating the City's website and making sure that the current programs are on there.
- The Energy Transition Community Grant program that we did last year and were approved \$55,482.00 to do the engineering work on Plum Street (Streetscape Phase B). This is a second round of the Energy Transition Community Grant. I believe that since the City of Havana wasn't affected as strongly as some of these other taxing bodies, it's probably going to be about \$50,000.00. I need to have some direction on what project we would want to go for and then I can fill out the grant. Alderperson Cooper asked when it had to be submitted. Economic Development Coordinator, Brenda Davenport-Fornoff said, she would have to ask when it is due. The grant just became available in January. Alderperson Bryant asked if it could be used on any project or if there are stipulations? Economic Development Coordinator, Brenda Davenport-Fornoff said, there are stipulations on what it could be used for. It can be used for research, analysis, and planning regarding economic impact reduced or ceased operations of the regional facility, environmental remediation of sites of closed facilities and other local infrastructure improvements, marketing of tourist and recreation opportunities, business development initiatives to attract, expand, or retain employers, workforce development and support for individuals displaced by closures or reduced operations, including training for skilled trades in regional industries. Investment for construction or improvement in local job training facilities, financial assistance for unemployed, underemployed, and/or low-income residents, public health initiatives and other initiatives to address the economic and social impact of reduced production or closure of regional facilities. Mayor Stadsholt suggested, the City pathway from Orange to Market Street. We are doing a lot of business there. Mayor Stadsholt said, I don't see it as an alley. I see it as a business marketing opportunity for Havana. We have been approached by other businesses back there for improvements. I have never understood why we, the City of Havana, say we own the alleys, but we don't maintain them. If the city owns it, why don't we take care of it? Alderperson Griffin said he just put \$800.00 worth of gravel in his alley. Mayor Stadsholt said, we're always talking about creating jobs, and creating jobs at the Business Park, but could we create jobs for Public Works and more jobs for people to do that? Public Works Department Leadman, Jay Sarff said, you are looking at a lot of ground work. Some of these alleys have some pretty decent potholes in them that would take a whole truck or two truckloads of rock per hole. It would take a whole lot of gravel and a whole lot of time. Fire Marshal/Zoning Officer, Matt Fliege said, we don't own the alleys. The alleys that are maintained by us briefly, are only because either a sewer or something goes down through that way. An alley is just a public thoroughfare. It is more of an easement rather than the City owning it. It is similar to the strip of grass between the sidewalk and the street where residents take care of the maintenance but the City has easements for sewer and water.
- Mayor Stadsholt said, Brenda and her had been invited to a meeting on November 7, 2023 concerning the possibility of an Enterprise Zone from Fulton County extending into Mason County. We were involved in another phone today for an hour with Kathie Brown and Sally Hanley with Greater Peoria Economic Development Council. Brenda and I agreed that it would be great to have an Enterprise Zone from Fulton County extend to the coal docks and helped all of our local people working on that project or if it is extended to the Business Park. We are interested in anything that would help us, the City of Havana, but we will let the county take the lead on this.
