It was my money that refurbished the buildings that I own. Those of you that don't know I own Blue Butterfly Resale Shop, 311 ½ Lodging on Main, the current Edward Jones building and two empty properties in between Gathman Auction Company and Edward Jones. With some of the programs Economic Development Coordinator, Brenda Davenport-Fornoff has given us, like the Blade Sign Program and the City of Havana Downtown Building Mural Program. I have taken advantage of some of the money that has been available. Adding 1% would make a huge difference in helping those who are either already established or want to be established in Havana. I just really want to encourage the City Council as a business owner, as a consumer. 1% is nothing when I am paying a bill. The credit card fee is one thing that probably many of you don't even realize you're paying. When you go to a restaurant there's two different dollar amounts, one for cash and one for credit card. We at Blue Butterfly do the same thing we charge 3% because we are stuck with a 6% fee which is huge for a small business.

DISCUSSION: April Burgett, also a downtown business owner said, I would just say that I probably get calls from other communities at least once a month wanting to know. How did Havana do it? Can you talk to us? Can you give us advice? Where do you start? I always share the City of Havana's website, the Economic Development page, the initial Building Survey and all of the documents that were prepared by 353 Court, LLC. They're still a really valuable resource to just demonstrate. Usually my first question is, do you have money? Because really nothing could have happened ever without money. If they don't have a TIF program and they don't have any funds it's really hard to give them advice on what to do. Because it is the financial part that can be the hardest barrier. I feel like referring back to that forward thinking that the City Council and Mayor did for TIF in 1987 that set us up for a lot of success, because it was used properly when it was spent out and finished. And I feel like 30 years from now. There may be people who say it was a good thing that we did the Business Development District.
