I have spoken to Brad Watson. They're excited to work with Havana and excited to be doing this particular project. They will employ a lot of people for the construction process. Perhaps as time goes by there may only be about six employees. He's not for sure at the power plant, but there'll be a lot of construction going on between now and 2025. So it's good news for our community. Good news for the tax bodies that really relied on the power plant.
- I did go ahead and sign the CDBG Infrastructure Grant, as we asked you last month to approve so that has been submitted to them and we'll wait to hear from them. Whether we the Havana community will receive an infrastructure grant from CDBG.
- Brenda and I are working with Kathleen Brown from Peoria Economic Development. We are trying to help her and help Bradley University. They have a senior learning institute as we did at Spoon River College, but at Bradley it is called OLLI and they'd like to come down from Bradley with their people for a couple days in the fall for a trip to Havana and that's very good news for us. It's a Bradley learning institute just as had it at Spoon River College for the senior citizens.
