PUBLIC WORKS REPORT

DISCUSSION: Public Works Director, Jewel Bucy reported on the following items:

- Donnie Green last week took our garbage truck out to the Junior High for the Early Childhood Council Fall Festival.
- Yesterday we got the approval from the Illinois Environmental Protection Agency on our loan application. Now, we are required to have a public notice in the paper, allowing 10 days for public comment. If it passes then we will put it in the application for the loan; if that passes we can start on a new design. The City of Havana's Wastewater Treatment Plant was initially constructed in 1939, consisting of a grit chamber, bar screen, clarifier, digester, and drying beds. In 1973, the Treatment Plant was revamped to include a grit chamber, manual bar screen, aeration tanks, secondary clarifiers, aerobic digesters, and drying beds. The City intends to upgrade the grit removal facilities, replace the bar screen and comminutor with an automated fine screen and manual bypass screen. Replacement of air piping and diffusers in aeration tanks, scraper mechanisms, weir plates, baffle plates, and troughs in the secondary clarifiers. Air piping and diffusers in the rectangular digester will also be replaced. The removal of old clarifier components, gout the perimeter trough to prevent standing sludge and the installation of new air piping and diffusers in the circular digester will also take place. Repairing concrete walls in the splitter chamber and repainting handrails around all of the tanks is also needed. The City also intends to replace submersible pumps located inside the Washington Lift Station.
- Eric Shangraw, from GFL Environmental in Hopedale, is wanting to give us an estimate on tipping fees. They always raise their prices in August.

- Maurer-Stutz, Inc. was down last week doing surveying for the Plum Street project. Keith Plavec, with Maurer-Stutz, Inc. sent me an updated schedule for this project. Environmental Clearance Submittals (EcoCAT, PESA Screening & SHPO Clearance Letters): September 22, 2023 Survey Base File Development Complete: September 29, 2023 Preliminary Plan Submittal: November 10, 2023 ROW Verification: November 30, 2023 Preliminary Cost Estimate: December 13, 2023 Public Meeting: December 13, 2023 PreFinal PSE (90%): February 15, 2024 Final PSE (100%): March 15, 2024 Tentative Letting Date: March 29, 2024.
- As you can see, the TBK curb is all tore out. I planned on putting a curb through and then putting a
 three or four foot pan in for people's front wheels, but something dawned on me at home and I said,
 why don't we just make that a whole parking lane and it would match the downtown. I think that's
 what I'm going to do. We'll just go as far as my money will take us.
- I talked with a guy from Long Creek Illinois today. He is an operator down there and he is actually doing what I would like to do. He is slowly integrating this Zenner meter into his meter system and he said it is working really great there. He said he is so glad they got them because they don't have to worry about replacing batteries. I can get us started for \$50,000.00 that is with forty new meters, antennas and a new computer. I would like to use \$50,000.00 out of the ARPA funds on that project and get that initiated to get started.
- We flushed water mains about three weeks ago and we had three water main breaks and two of them
 were on the weekend.
- We have been working on the streets up on Plum Street.
