#### **PUBLIC WORKS REPORT**

**DISCUSSION:** Public Works Director, Jewel Bucy reported on the following items:

- Tomorrow IRC Inc. is going to start on the trap rock for our oil and chipping program and they are going
  to do part of Schrader to Franklin, a couple of streets over here on Adams and Washington for about
  two blocks each and Main Street from Broadway to Promenade.
- The sidewalk project is going pretty well. There have been a couple issues but everything's working out
  real well. They're going to pour concrete in the morning on the west side of the driveway on Charlotte
  Street. They are going to be hauling gravel in and putting in the base course for asphalt. They are going
  to do the asphalt as soon as they can because the company will be shutting down for the winter.
- I did get some good news. The windmills are actually done for the year. They are not probably going to start up until late April of next year.
- We spent about \$8,500 on the Jet/Vac truck due to everything rusting out.
- I gave the sophomores permission to use the annex building for their float.
- I think all of you know, but we have to do a mussel survey because of EPAs regulations and this is Bridget Barry from Farnsworth Group and she's going to explain the mussel survey. The mussel survey was triggered by public comment not about Havana specifically, but about multiple locations along the Illinois River. So cities as big as Peoria are having to do this mussel survey. Unfortunately, we don't have one that we've done in the past five years. While lots of other towns do for other reasons. So that's going to be a cost for us now. The reason that it's triggered is because our ammonia levels coming out of the wastewater plant are higher than we typically like to see. So we have to spend this money now to check to make sure that the ammonia levels aren't hurting any of the wildlife and the easiest way to do that is to check the mussels. The alternative is we don't do this mussel survey and we implement ammonia treatment within the wastewater plant which would be a large expensive and a long project, but I don't think it's necessary whatsoever. So we're going to do this mussel survey and I've checked with a few other engineering firms and other contractors to see what kind of mussel survey teams they use and I've only found one that has any availability for the rest of this year. We have to do it before

the water gets too cold and it is nearing that time. So the one proposal that I've been able to receive is from EcoAnalysts, Incorporated and they provided that quote to me yesterday and I shared that with Jewel and the Mayor and it is \$12,228.00. They will coordinate with the EPA to make sure that all of the requirements are hit and I have lots of references for the specific company and I feel comfortable recommending them to you. So that's where we're at, it's an unfortunate cost that we weren't expecting, but to get our permit to continue to operate the wastewater plant it is necessary.

This is a local business, we have used this company many times before. In the meantime, the structure has gotten worse. We've been over there a couple of different times with police officers, because we think there are people that are still going in and out of it. Even though we did have it secure, but it has gotten worse since my last report on it. So again, this will be put on to a lien, so whoever tries to pick it back up, we'll have to satisfy our costs as well.
